OPENING STATEMENT - CHRISTOPHER J. WORRELL PARDONED POLITICAL PRISONER & TORTURED HOSTAGE BEFORE: J6 INVESTIGATIVE COMMITTEE

SUBJEST: TORTURE & CRIMINAL MISTREATMENT OF JANUARY 6 PRISONERS

My name is Christopher John Worrell, a Pardoned Political Prisoner & former Biden Regime Political Hostage.

I understand this committee has been convened to hear testimony and obtain potential evidence regarding the criminal neglect and abuse of inmates and/or prisoners within the Department of Corrections and the Bureau of Prisons.

First, I would like to personally thank you all for this opportunity while also bringing recognition to the sacrifices you all made over the last 4 ½ years to bring the truth regarding January 6, 2021.

I come before this honorable committee of my own free will to give sworn testimony of my intimate knowledge of the intentional, unconstitutional, criminally immoral, and inhumane mistreatment of January 6 inmates and prisoners across the United States.

I have personally experienced and witnessed the immoral dismissal of human life in these facilities as I have been in no less than twenty-one (21) Jails and Prisons in six (6) different states across this country from March 2021 through January 2025.

Let me be clear..... ALL of the criminal treatment I endured since my arrest on March 12, 2021, along with hundreds (100's) of other J6'ers, is one hundred percent (100%) a direct result of a treasonous weaponized government that includes the White House, Biden Administration, Pentagon, Congress, DIA, CIA, DHS, DOJ, US Marshalls, District of Columbia, Department of Corrections, and the BOP just to name a few of those directly responsible.

Due to my presence at the Capitol on January 6, 2021, The United States Government has also labeled me a "Domestic Terrorist". and I have personally seen this title in my file on BOP computers. I was also treated as such in many facilities and while in US Marshalls custody.

After my arrest on March 12, 2021, I finally arrived at the DC Gulag on April 13, 2021after some major "diesel therapy" by the US Marshalls and the BOP. During intake at the DC Gulag it was immediately apparent that I was in enemy territory.

The next five (5) months were by far the worst times of my life. We filed countless court motions including "EMERGENCY MOTIONS" that resulted in EIGHT (8) court "DENIALS" to go home for proper medical treatment due to being labeled by Judge Howell as a "danger to his community". Judge Howell also ignored my treating doctor's affidavits and dozens of character letters from my community in Florida.

Almost immediately J6 inmates were reporting the deplorable conditions and treatment they were receiving at the DC Gulag. The solitary confinement, officer assaults, lack of medical care, denial of basic grooming and much more intentional mistreatment occurred. Congress, the DOJ, and the Biden regime were all aware of the intentional persecution and torture.

On October 13, 2021 an "ORDER OF CONTEMPT" was filed by Federal Judge Royce C. Lamberth against DC DOC Director Quincy Booth and Warden Wanda Patton of the DC Gulag. Judge Lamberth referred the "CONTEMPT" to the Attorney General of the United States Merick Garland for appropriate inquiry into the "potential civil rights violations of January 6 defendants, as exemplified in this case.",

The evidence gathered by United States Marshals before and after the "Contempt Hearing" on October 13, 2021, proved the DC Jail and Unity Health Care doctors and staff were intentionally manipulating my medical records further proving there was *intent* to cause physical harm and/or death. **THAT** is at the very minimum "Aggravated Assault" and leans heavily towards "Attempted Murder" due to intent. Despite a federal judges referral the DISHONORABLY TREASONOUS Attorney General Merrick Garland did NOTHING regarding the blatant deprivation of civil rights against an American citizen further proving complicity in the "FEDSURRECTION" and bias against J6'ers.

"Coincidentally" ALL of that happened simultaneously with every court filing and court hearing where the prosecutor(s) William Dreher & Alexis Loeb maintained, "Worrell is being treated" despite being DENIED my previously prescribed cancer medications by Dr(s) Mitchell & Crenshaw as well as blatantly ignoring orders from Howard University doctors' while in custody of the DC Gulag in 2021.

On 4 November 2021 Judge Lamberth ordered me "REMOVED IMMEDIATELY" from the DC Gulag stating... "as evinced by the findings of the U.S. Marshals in their investigation, this Court has zero confidence that the D.C. Jail will provide the treatment required by the defendant's condition and that the D.C. Jail staff will not retaliate against Worrell as they recently have against other prisoners and detainees"

On November 6, 2021, I arrived back to my home in Naples, Florida Under strict "Conditions of Release". I was monitored by GPS ankle monitor, mandated to 24-hour house arrest, and **DENIED** the ability to use the internet or speak to the media per Judge Lamberth. **ALL** conditions of release were a continued violation of my civil rights under the Constitution of the United States. Those same Unconstitutional orders also further endangered my life as they delayed my immediate medical treatment.

Finally in January 2022, after eleven (11) months of inhumane torture, I received the results of multiple medical tests. It was determined that my Non-Hodgkins Lymphoma had accelerated to a Stage-3 condition, and it was also discovered that bone deterioration was present in my lower jaw Due to what can only be a direct result of medical neglect and malnutrition.

During the next twenty-two (22) months of pre-trial I went through dozens of hearings and multiple superseding indictments. In every court filing and oral hearing, the prosecution maintained that I was "FAKING", "FABRICATING" and "EMBELLISHING" my illnesses. Those relentlessly malicious and unanswered allegations combined with anxiety and PTSD that I was suffering with at the time induced a very real "fear for my life" concern.

On August 14, 2023 I cut off the GPS ankle monitor and fled not telling anyone where I was going or even that I was going to take off. I was "scared for my life" due to the mistreatment I endured and watched others endure while in custody.

On September 28, 2023 I was back in custody, and it didn't take long for my testimonies of predicted mistreatment to manifest into reality. For seven (7) months I was given "diesel therapy" and moved to 12 facilities across the country. Five (5) of those twelve (12) stops were to the same two (2) facilities despite being "designated" to Butner FMC in North Carolina.

On May 3, 2024 I was extracted by US Marshalls from Tallahassee FDC and taken to Butner FMC **ONLY AFTER** countless phone calls and emails by many people across the country including Congress offices.

The BOP in multiple facilities also fabricated and lied in my medical records, and made medical prognosis(s) without any examination(S) or diagnosis. After nearly six months (6) at Butner FMC I was abruptly removed and sent to the FCI Low facility down the road after attempting to file grievances on nurses and finally forcing my counselor to file a grievance against an officer that made direct threats to me.

All of this criminally intentional malicious life-threatening mistreatment I endured has been documented in medical records, my own notes, messages, court filings, and transcripts of hearings

Along with my statement today I have submitted Eleven (11) Evidence Exhibits that corroborate my statement here today.

In closing, the deprivation of civil rights and treasonous crimes of humanity perpetrated against myself, and hundreds (100's) of other J6'ers along with countless other inmates and prisoners needs to be corrected immediately.
