The United States Sentencing Guidelines (USSG) are clear that "[t]he court shall impose a fine in all cases, except where the defendant establishes that he is unable to pay and is not likely to become able to pay any fine." USSG s. 5E1.2(a). When determining a fine, 18 U.S.C. s. 3572 requires a court to consider, among other things, "the defendant's income, earning capacity, and financial resources." 18 U.S.C. s. 3572(a)(1). An accounting will aid the Court in determining whether Defendant is unable to pay a fine. Although a fine, if imposed, is indeed part of the statutorily permitted punishment for the crimes of which she has been convicted, to the extent that the money raised by her GiveFundGo account has gone to payment of legal fees, the Court is unlikely to find that amount relevant in determining the size of such a fine. See, e.g., Tr. of Sentencing at 86-87, United States v. Lavrenz, No. 23-cr-66 (ZMF) (D.D.C. Sept. 19, 2024), ECF No. 103 (noting that money raised to pay for legal fees was not part of the fine imposed). Accordingly, by November 8, 2024, Defendant shall file with the Court an accounting of her GiveFundGo account that details the amount of money collected through it, how that money has been used, and the amount of any remaining money in the account.
